Abstract from Sewer Ordinance prescribing rules, regulations, conditions and restrictions as to connection with and use of the sewers and drains of the sewage system of the Borough of Clarks Summit.

- 1. Every owner of property upon which there are erected occupied buildings or premises which is or are accessible to a public sewer of the Borough shall connect such building or premises to such public sewer within nine months from the date when such public sewer is available for use.
- 2. No building or premises shall be connected with any sewer without a permit first obtained from the Borough Manager. Permits so obtained shall be kept on hand during the progress of the work to which they relate and shall be exhibited whenever required. For each permit granted a fee of fifty dollars (\$50.00) will be paid by the applicant.
- 3. Plans and specifications for outside drainage shall be submitted to the Sewer Inspector and Sewer Committee for approval.
- 4. Plans will be approved or rejected within twenty-four (24) hours when practicable, and under no circumstances will a delay beyond ten (10) days be permitted.
- 5. It shall be unlawful for any person, firm or corporation to cut, break into, excavate or open any of the streets, avenues or highways of the Borough of Clarks Summit or any portion thereof for the purpose of connecting a house drain to a street sewer therein without first making written application to the Borough Manager, stating the kind and character of the proposed excavation and obtaining from said Borough Manager a permit for each and every opening.
- 6. No privy vaults, cesspools or similar receptacles for sewage shall hereafter be constructed in any part of the Borough where a public sewer is at all accessible, nor shall it be lawful to continue the use of any cesspools or similar receptacles for the disposal of sewage on any lot, piece or parcel or ground abutting on or contiguous to any public sewer within the Borough limits, except for the disposal of domestic sewage deposited in plumbing receptacles placed at too low an elevation to be served by a public sewer. All prives or privy vaults, heretofore constructed on land accessible to public sewer shall be abandoned and the vaults cleaned and filled.
- 7. The Borough Manager will not permit the connection of any drainage system to the public sewers until the inside drainage system shall be examined and approved in writing by the Sewer Inspector.
- 8. The discharge into the public sewers of acid or alkaline wastes from public laundries, dye houses, public garages, bottle works, mills, factories or other industrial establishments, shall only be permitted in such cases as it shall be proven to the satisfaction of the Borough Sewer Inspector that such discharge will not deleteriously affect the treatment of sewage by the municipality.
- ** 9. No water from the roofs of buildings, no surface water, foundation and cellar drains, or similar appliances shall be permitted to be deposited in the public sewer and the Borough Council shall have authority to order the Sewer Inspector to disconnect the drainage of any person or corporation failing to comply with the provision of this ordinance. No person, firm or corporation shall injure, break or remove any portion of any manhole or any part of the sewer system, or throw or deposit or cause to be thrown or deposited, in any sewer opening or receptacle connecting with the sewer system, any garbage, offal, dead animals, vegetable parinecessary water-closed paper, liquid house or mill slops and water; except faeces, urine, the placed any bulky substance in any sewer opening, or in the house connection or private drains flowage in said sewer or to damage them in any way.

A 300.00 dollar fine will be imposed for every day said violation is allowed to exist.
